Yellowwood State Forest will be selling logs and accepting online bids.

The bids for Mixed Grade Log Sale (Orange Paint) will be due by 7:00 am, Thursday, September 25, 2025. The logs will be available for your viewing at the tract (see map) from now until the close of the bidding. The successful bidder must make payment to the property before logs can be removed or within 3 business days of the sale conclusion and the purchased logs removed within 14 days of the bidding deadline.

To bid on the logs, you do have to have an active timber buyer's license and agent registration, but you do not need a performance deposit to successfully bid for and purchase these logs. The Division will be responsible for loading logs on buyers' trailers. Buyers are responsible for trucking logs from the log landing.

Payment is to be made by check only at the office of Morgan-Monroe State Forest before any logs are to be hauled away. Checks can be made out to the Indiana Department of Natural Resources. Below is an estimate of grade and volume for each species, but each bidder must satisfy themselves to the species, grade and volume being offered.

Log grade definitions:

Grade 1 – 16" small end diameter - 2 faces clear

Grade 2 – Small end diameter less than 16" – 2 clear faces

Only current licensed buyers or their registered agents may submit bids. Buyers should satisfy themselves as to volume in sale.

Logs are laid out on the firelane past the prentice boom. A key for the cable gate is hanging from the tree with the area closed sign at the left side of the gate. It will be for the green pad lock.


